

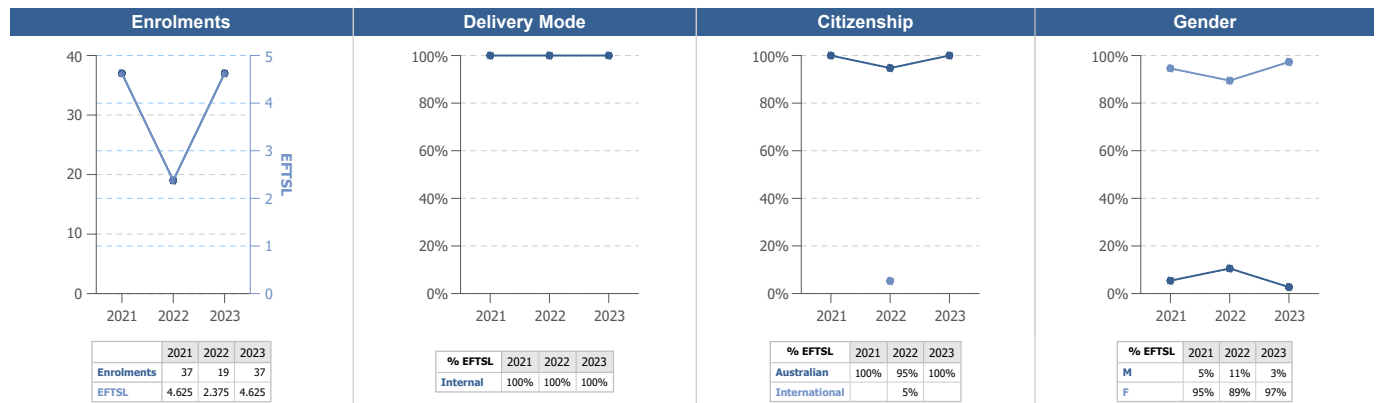

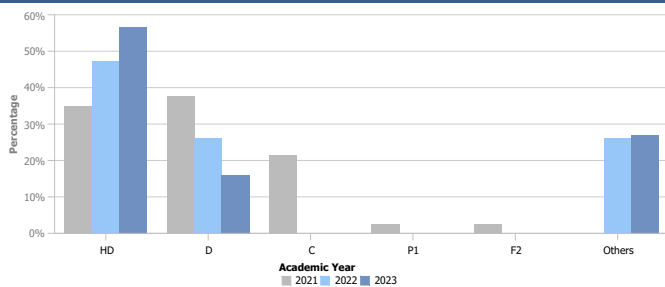

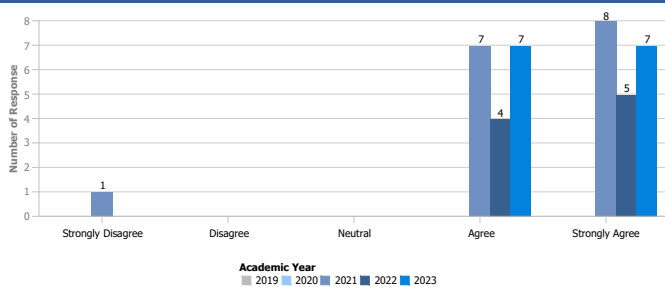


Grade Distribution

Course Overall Satisfaction

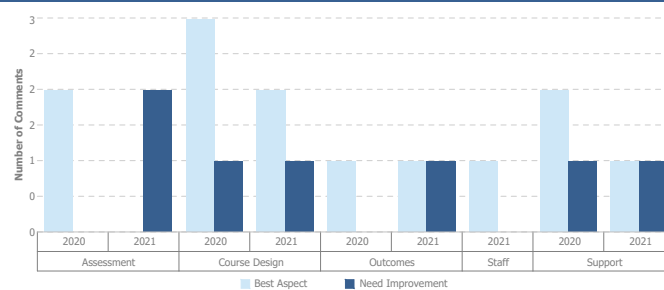

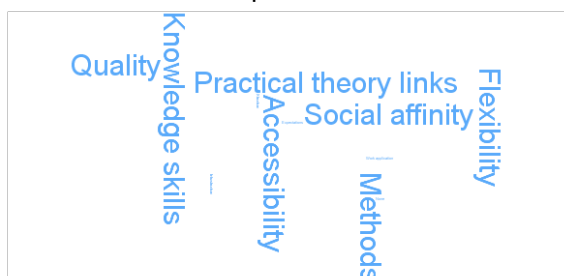

SP2 - 2022	ICBR	Do not need to do the physics section. Would have been more helpful to have another week on breast ultrasound images or just artifacts. It was a handy overview/review, but maybe less focus as there is already a physics course. the Part D presentation would have been more helpful if it wasn't on the work practice for ICBR. I probably would have learnt more if I could select a specific pathology and do a presentation on that. Would have been interesting to the watch others and learn even more.

Despite doing it correctly I found creating the certificate for part A simtics very hard to find. Maybe a document or video is needed to show the correct process as I found it very time consuming to work out the required process.
